- * You have to pay some or all of your tax refunds to the trustee's office by May 1 each year. You must pay:

All amounts over \$2,400.00.

- * You have to pay some or all of your bonus income to the trustee's office. Payment is due within 30 days after you receive your bonus(es). You must also give the trustee's office a copy of the paystub(s) showing the bonus(es) you received. You must pay:

33% of the gross (before taxes) bonus.

- * You have to give a copy of your tax returns to the trustee's office by May 1 each year.

- * You have to give a copy of your year-end paystub to the trustee's office by May 1 each year.
